- First chair of jury trial representation of the author of *Point Break LIVE!*, a parody of the 1991 action film *Point Break*, in her lawsuit against a producer for breach of contract and copyright infringement. Result: unanimous verdict and damages award for client—one of only a few trials nationwide in which a jury has decided "fair use" under the Copyright Act. *See Keeling v.
